- (9) Dr. M. L. Madan will be contacted by DDG (AS) and the President, NAVS (I) regarding bringing a publication of 100-150 pages on the title "Indian Livestock Scenario: State and way forward". There will be a committee for this publication comprising of Dr. M. L. Madan, Dr. Lal Krishna, Dr. J. S. Bhatia, Dr. S.S. Honnappagol
- (10) The President NAVS (I) will write about the Academy to NASI, INSA
