Proceedings of meeting for deciding the NAVS calendar of events for three years

An online meeting was arranged to discuss and decide calendar of NAVS events via Zoom on 7th March 2024 at 03:00PM (IST) under the chairmanship of NAVS Vice President Prof (Dr.) A.C. Varshney. The meeting was attended by the following:

- 1. Dr Yashpal S Malik, GC Member, NAVS
- 2. Dr RajeswariShome, GC Member, NAVS
- 3. Dr Neelam Bansal, GC Member, NAVS
- 4. Dr JyotiPalod, GC Member, NAVS

Dr M Chatli, GC Member, NAVS, member of the committee couldn't attend the meeting due to official engagement, however Dr Chaitli forwarded his views for consideration.

In the welcome remarks, the chairman of the committee and Vice President Prof (Dr.) A.C. Varshney conveyed his gratitude to the committee members for their presence. He apprised the house regarding the NAVS calendar of activities needed for the Academy for next three years. The calendar of activities are perceived by many senior NAVS fellows and the past and present GC to fulfil the aspirations of the Ministry of Fisheries, Animal Husbandry and Dairying (Min of FAH&D) and Veterinary Council of India for the recognition of the Academy as a "Technical Resource/Advisory Body". The committee deliberated on the issue in the zoom meeting and brief outcome points are as follows:

1. Every year in the first week of January, a GB may be convened in physical mode/virtual mode.

2. The committee decided to draft three years calendar with one NAVS Annual Convocation with a probable fixed month in a year for conducting this convocation (October every year) and topic of technical programme of convocation may be decided in the GC meeting in first quarter of the year.

3. NAVS may organize four quarterly technical brainstorming, symposium or seminars every year (altogether 12 in three years; 2 each virtual and 2 each in physical mode) coinciding with NAVS GB meetings. It has been decided to conduct

these brainstorming/symposium/seminar at different parts of the country to facilitate the regional NAVS fellow's participation physically. These brainstorming, symposium or seminars are proposed to be conducted in collaboration with VCI, ICAR, PVT institution/ NGOS, veterinary universities and state animal husbandry departments on various topics like One Health, Continuous Veterinary Education (CVE), Rabies, Transboundary Viral Diseases in Livestock, any emerging theme, etc. 4. NAVS calendar for seminars/ symposium/brainstorming may align with International women's day (8th March), world veterinary day (last Saturday of April month), world zoonoses day (6th July) and One Health day (3rd November). 5. It is proposed to celebrate NAVS foundation day (registration date of NAVS) in consultation with the President NAVS.

The meeting ended with vote of thanks to the chair and members.
