The President apprised the house regarding his interactions with various authorities and organizations in the recent past. The President informed the house that he, as member of Board of Management of TANUVAS had interaction with the visiting team of German Veterinary University at Chennai. The visiting team invited him to attend the forth coming Indo-German Vet

Workshop in the capacity of President NAVS (I). He along with the representatives from TANUVAS, GADVASU, WBUAFS, BASU, NDRI, IVRI, NIANP, ICAR will be attending the Workshop with effect from 28-30 Apr 2025 at Leipzig, Germany. The President mentioned that it will be an opportunity for him to seek funding from German University for the Academy to undertake some Collaborative Project. Further, the President sought proposals from the GC members to make our Delhi office more active/functional.

- (i) **Promotion of Continues Veterinary Education (CVE)** – The Academy in collaboration with GADVASU and Director Animal Husbandry, Punjab has conducted two Short Terms Courses of 4 days duration (Aug 2024 & Feb 2025). Forty Field Veterinarians have attended the above Course. The feedback from the participant is quite positive. Similar Courses have been conducted at TANUVAS, Chennai during Mar 2025. These Courses were sponsored by Brooke India, an Associate of our Academy. Brooke India has extended their support to the Academy for organizing such short term courses for Field Veterinarians of Bihar State.
