(c) Review of Guidelines for Carcass Disposal: - The Draft document on Guideline for Carcass Disposal forwarded by FSSAI was circulated among the GC Members. The comments, suggestions received will be forwarded to the concerned agency for incorporate in final document.

(i) Establishment of ICF&VR - The President apprised the house regarding recent discussions held in NAAS against establishment of ICF&VR. The issue was deliberated and it was decided that we need to hold a meeting/discussion with eminent Fellows/Stakeholders to form a Strategy /Action Plan to pursue the above matter. The GC Members are requested to forward names with contact details (Mobile number & Email id address) of Stakeholders proposed to be called for the meeting.

(ii) Regulation for Carcass Disposal – Maj Gen ML Sharma (Retd), Secy Gen, informed the house that on behalf of the Academy, he has attended a Seminar on “One Health” organized by RVC Centre and College, Meerut on 12 Jul 2025. During deliberations, he had raised an issue regarding the challenges of implementation of Guidelines on Carcass Disposal. Dr Sangeeta Aggarwal, Scientist-F, representative of Principal Scientific Advisor to Govt of India, suggested that the Academy need to take up the issue with concerned Ministry’s to formulate “Regulations” for Carcass Disposal.

Gen Sharma, proposed that the Academy should organize a Seminar on One Health by inviting Principal Scientific Advisor, legal experts and policy makers from the concerned Ministries to deliberate the issue. The President approved the proposal.
